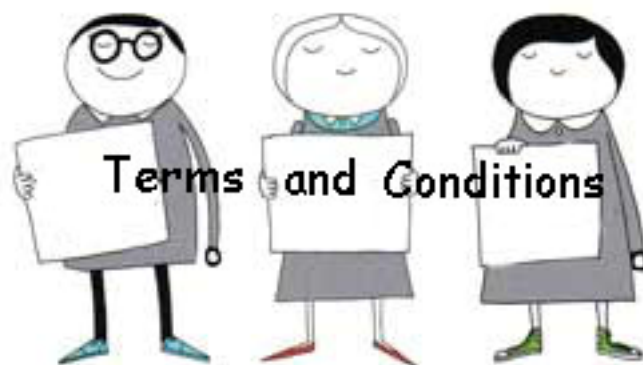


## TERMS AND CONDITIONS OF USE – v1.9
